Dear Counselor-in-Training 2 Applicant:

Thank you for your interest in our C.I.T. II program. This exciting program gives girls entering 11th and 12th grades the opportunity to sharpen and extend the skills they learned in CIT I.

To apply for C.I.T. II you must fill out the enclosed application, complete an interview and have two people (who are not related to you) to fill out the enclosed reference forms. It will be helpful to supply your references with a stamped envelope addressed to this office, as well as to fill in your name at the top of the form.

This year the deadline for applications is April 20, 2019. If space allows, applications received after this deadline will be considered on a first come, first served basis. This is a selection process - it is not done by registration alone, so please get your application in on time.

Once we receive your application and reference you we will contact you with information about an interview. It may be a group interview in person at the Girl Scout Headquarters or over skype/FaceTime (if you are out of the immediate area) based on availability of the Camp Scherman Leadership Staff. Please remember that this is a selection process - acceptance to the program is not based on registration alone. Applicants will receive notice of their acceptance the weeks following the mandatory interviews. Interviews will be held in May.

Once at camp, you will spend the first few days primarily in the unit for orientation, review of skills and in-depth training to develop leadership, teaching and interpersonal skills. CIT II's will be able to participate in a series of unit and program stays in a variety of areas to provide hands-on experience. During this time, you will also have special sessions with the Leadership Staff to evaluate and improve your performance. CIT's will also participate in camp activities when not doing Leadership programming.
