Through progression, Girl Scouts build skills to become lifelong travelers and global citizens. Girl Scouts take the lead in planning a new adventure at every level.



Travel Paperwork Timeline

The timeline below gives troop travel paperwork due-dates. The levels correspond to the Travel Progression descriptions in the Troop/Group Travel Guidelines.
