Gold Medalist and NBC
Sports Analyst**



At just 15 years old, Lipinski made history and gained international recognition as the youngest Olympic gold medalist in the Winter Games. The iconic Olympian thrived in the high-pressure world of competitive sports and understands the importance of mental wellness. Beyond figure skating, Lipinski has written two inspirational books and works as an analyst for NBC, covering figure skating and the Winter Olympic Games. A new mom, Lipinski recently went public with her 5-year struggle with infertility before welcoming her daughter through surrogacy. She is a vocal advocate for mental health awareness.
